### **Interconnection Architecture**

#### **National Interconnection Sites**

Orange Business Luxembourg S.A. (hereafter Orange Business Luxembourg) has one site that has been designed for use as National Interconnection Access Point. This is an existing manned Orange Business Luxembourg's site, containing relevant switching and transmission equipment with all digital functionality for national and international traffic. The address of the interconnection point is:

Orange Business Luxembourg, 201 Route de Thionville, L- 5885 Howald Luxembourg

In case of national interconnection, the offered Interconnect Services relate to the entire national area.

## **Regional Interconnection Sites**

Orange Business Luxembourg has **no** site that has been designated for use as Regional Interconnection Access.

## **System Alteration**

If Orange Business Luxembourg wishes to make a system alteration, it shall give the OAO and the ILR no less than 6 months written notice prior to the date of the anticipated system alteration. The notice shall specify the technical details of the system alteration and the date of the anticipated system alteration. Following such notification Orange Business Luxembourg shall supply to the OAO such information as the OAO may reasonably request including, to the extent reasonably practicable, the potential impact on the service provided by the OAO to the End Users.

#### **Standards**

Where relevant for interconnection with Orange Business Luxembourg, the following hierarchy of standards and procedures will apply:

- Any legal requirements
- ETSI standards
- ITU-T Recommendations
- National standards
- Any other international standards

The signaling system will be based on the ITU-T SS7 protocols, ISUP Blue Book version. Tests for the SS7 will be performed following the pertinent ITU-T recommendations such as Q781-Q785. The transmission level of the interconnection is based on the pertinent ITU-T recommendations for PDH and SDH interfaces .

#### **Interconnection Link Services**

The interconnection link service consists of the physical link between an Orange Business Luxembourg's Access Point and an Operator Access Point. The Interconnection Link provided by Operator carries a number of 2 Mbit/s links.

Orange Business Luxembourg ensures the availability of only following Interconnection Link Service for the conveyance of the Operator's traffic:

Orange Business Luxembourg sited interconnection

### **Orange Business Luxembourg -sited Interconnection**

For Orange Business Luxembourg -sited interconnection, the operator will supply and operate an Interconnection Link in its entirety. The Interconnection Link will remain in the Operator's property.

The Point of Interconnection shall be located at the Access Point on the DDF (digital distribution frame) of the Party that has the operational responsibility for the Interconnect Link.

Orange Business Luxembourg will permit Orange Business Luxembourg -sited interconnection at the site identified in preceding Article 3.

In its request for Orange Business Luxembourg -sited interconnection, the operator will describe his needs regarding the installation of transmission equipment. Whenever Orange Business Luxembourg determines that Orange Business Luxembourg -sited interconnection is not reasonably feasible, it will inform the operator and the ILR of the reasons of such unfeasibility within 15 days of receiving the request. Orange Business Luxembourg will comply, should the ILR find that Orange Business Luxembourg -sited interconnection is reasonably feasible.

In case of non-feasibility of Orange Business Luxembourg -sited interconnection, Orange Business Luxembourg will cooperate with the Operator in order to find an appropriate alternative solution.

#### **Interconnection Links**

The tariffs for Interconnection Links are indicated in Annex 2.

The operator is responsible for the dimensioning and payment of the Interconnection Links required for the conveyance of its own traffic. An operator's own traffic consists in the traffic for which the operator is billed by the operator who it interconnects with. The operator is responsible for:

- the traffic conveyed through its System and handed over at Orange Business Luxembourg Access Point in order to use Orange Business Luxembourg Terminating Access Services.

The operator shall supply capacity requirements, forecasts and routing data every 6 months to Orange Business Luxembourg for a 12 months planning. This information will only be used by Orange Business Luxembourg for dimensioning of its network and will be kept strictly confidential.

The signaling systems between Orange Business Luxembourg and the operator shall be based, where relevant, on the ITU-T SS7 protocols, ISUP Blue Book version or other protocols to be agreed upon between the operator and Orange Business Luxembourg. At the transmission levels, the interconnection is based on the pertinent ITU-T Recommendations for PDH and SDH interfaces.

# **Quality of service of Orange Business Luxembourg 's Interconnection Services**

As far as the terminating access service is concerned, Orange Business Luxembourg undertakes to ensure for its own system a network failure rate, which does not exceed 1% as a national 3 months average, for failures which are exclusively due to its system. Network failure rate is the ratio between the number of calls handed over by an operator to be terminated on Orange Business Luxembourg's network and failed due to insufficiencies in Orange Business Luxembourg's network and the total amount of calls handed over by that operator to be terminated on Orange Business Luxembourg's network (excluding, in particular, failures due to end-user behavior and failure of terminal equipment).

In the event of disturbance of the conveyance of traffic within its system, Orange Business Luxembourg may be constrained to implement the classical measures of traffic regulation (call gapping, etc.) in order to limit its effect on the quality of the service provided to its customers as well as to the interconnected operators. These measures of traffic regulation are applied to Orange Business Luxembourg's and operator's traffic without discrimination. The target figures given above for network failure rate do not include failures that are caused by the mentioned measures of traffic regulation. The operator and the ILR shall be informed if the above-mentioned measures for traffic regulation have to be applied and how long they may last.

Orange Business Luxembourg shall respect the quality conditions as they are defined in the applicable legal regulation and in accordance with the quality Orange Business Luxembourg provides for its clients.

KPI's covering the provisioning time and fault repair time are always stated in the interconnection agreement.

## **Terminating access service**

The terminating access service conveys a call handed over from the operator's system, at an Orange Business Luxembourg's access point for termination on any national number of Orange Business Luxembourg network.

Tariffs may be different for different categories of services identified by different number ranges.

The tariffs applied by Orange Business Luxembourg for the provision of the terminating access service are indicated in Annex 1. Only calls that have been setup successfully and answered will be charged. The charging time starts with the answering signal and ends with the first clear signal generated either by the calling or the called party.

Whenever CLI is transferred to the telecommunications network of Orange Business Luxembourg, Orange Business Luxembourg will not communicate such CLI to an end-user if such CLI is marked as CLIR unless the call is directed to an emergency number.

### **Originating access service**

Orange Business Luxembourg does not offer any originating access service from its network for operators.

#### Transit access service

Orange Business Luxembourg does not offer any transit access service towards its network for operators.

### **Leased Lines Interconnection Service**

Orange Business Luxembourg does not offer any leased line interconnection service on its network for operators.

#### **Number Portability (NP)**

#### Scope

Number portability (NP) is applicable under the conditions defined by the document DOC-NP-ILT which describes the procedures applicable to number portability in Luxembourg (the NP-Document).

As defined by the NP-Document, the recipient operator transmits the electronic file containing the requested data to Orange Business Luxembourg by means of an electronic messaging system.

The transmission of the electronic files can be operated between 06.00 and 18.00 hours from Monday to Friday, except legal and public holidays.

Orange Business Luxembourg will acknowledge receipt of the transmission file by means of the same electronic messaging system.

As defined in the NP-Document, requests can be transmitted in timeframe T1+n .. T1+m.

For Orange Business Luxembourg, n=2 weeks and m=16 weeks.

NP will be activated by the Orange Business Luxembourg from Monday to Friday from 8.00 to 12.00 and 13.00 to 17.00 hours except legal and public holidays in Luxembourg.

This time schedule may be extended to 7.00 to 19.00 hours on Monday to Friday and 8.00 to 12.00 hours on Saturday with the supplementary costs to be paid by the recipient operator.

#### **Tariffs and Billing**

Tariffs of number portability will be those defined in Annex 1.

#### **Request form for Number Portability**

The template of the request form to be used for number portability is agreed during number portability service establishment.

## Tariffs Applicable to the Terminating Access Service of Calls Originating outside of the EEA

Orange Business Luxembourg will apply, based upon the country of the calling party number, a surcharge for the termination in its network according to the following rules:

- 1) Termination of calls with A-Number belonging to any of the Country Codes included in Table 1 : Orange Business Luxembourg will not apply any surcharge.
- 2) Termination of calls with A-Number belonging to any of the Country Codes included in Table 2 : Orange Business Luxembourg will apply a surcharge of 4,5 €cts/min.
- 3) Termination of calls with A-Number not belonging to any of the Country Codes included in Table 1 or Table 2, with no A-number (no CLI), with incorrect A-Number (either in format or content), invalid A-Number, modified or manipulated A-Number: Orange Business Luxembourg will apply a surcharge of 12 €cts/min.

These surcharges will be applied in addition to the termination rate specified in this RIO.

#### **Modification of Interconnection Links**

The establishment, the modification and the cancellation of trunks, as well as the connection or disconnection of circuits or signaling links required by an operator, are charged to this operator if these changes apply to existing interconnect trunks. The necessary changes related to the extension of an existing interconnect trunk by adding supplementary interconnect links are not charged to the operator.
